Booking Deposit: will be invoiced if you are successful in your bid. (Bookings will also be confirmed via email)

Balance: Payable 8 weeks before voyage

As a charitable organisation we do not under normal circumstances refund deposits for cancelled voyages. If DSP are unable to go ahead with the planned sailing dates due to controls placed on us within the Scouting Association or due to equipment failure, we will move the dates or refund monies paid.

This declaration must be signed by the section leader, or organiser of the group.

1. I consent to the group taking part in a voyage with the Discovery Sailing Project.
2. I will provide details of any medical, physical or other conditions which might affect the performance or safety of all.
3. Both the group and my-self will comply with the rules, regulations and instructions given to us by the Sea Staff during the voyage.
4. The Scout leader with the Nights Away permit is responsible for agreeing the sleeping arrangements on board
5. The group including group leaders will not be disruptive, aggressive, violent, intimidating or display antisocial behaviour including bullying during the voyage and understand that any such persons not complying with DSP regulations on board may be asked to leave the vessel at their own expense.
6. I understand that the balance of the voyage fee is payable to Discovery Sailing Project 8 weeks before the voyage.
7. I have read and understand the Discovery Sailing Project’s ‘Conditions of Booking’.

CONDITIONS OF BOOKING



Any crew member who is under medical treatment requiring prescribed drugs or any crew member with a physical incapability should present us with a confirmation from their parents stating their medical fitness to take part in this activity, the condition and the drug being used. Additional leaders may be required to assist with welfare on young people with complex conditions

Personal effects may be brought but no responsibility is accepted for loss or damage to the personal possessions of crew members. Valuable articles should not be brought.

Crew members are expected to carry out the duties assigned to them by the skipper and afterguard (other trained and qualified crew). Any form of aggressive or antisocial behaviour is not acceptable. In the event of such behaviour the person concerned will be asked to leave the vessel at their expense.

The balance payment for the voyage must be paid 8 weeks before the voyage. The voyage fee is not refundable unless DSP are required to cancel due to Government guidance, or a formal directive from The Scouting Association, or for reasons of safety of crew or yacht, or due to equipment failure on the yacht.

Refunds for voyages cancelled or curtailed.

Voyages might be cancelled or curtailed due to operational difficulties or weather beyond the safe operating limits of the yacht. Curtailment of a voyage due to adverse weather is an inherent and unavoidable risk of sail training and, in that event, DSP staff will endeavour to make optimal use of the voyage within the limits of safety and reasonable comfort for those on board. If a voyage is cancelled or significantly curtailed, DSP will offer refunds of fees already paid, or an alternate voyage booking of the same duration will be offered for a mutually agreeable date.

For bookings made as a group, refunds or alternate voyage dates will be offered as a group.

Alternate voyage dates will be for the same duration but, in the case of bookings for one-off events or voyages away from DSP's home port, the DSP is not obliged to offer the same programme or itinerary.

Any third party fees levied in addition to the normal booking fee (for example, race fees or race insurance premiums) are typically non-refundable once paid. DSP will refund such fees only to the extent that DSP is able to obtain refunds from the third party, irrespective of the cause of cancellation or curtailment.

The provisions above set out the limit of DSP's liability for any cancellation or curtailment of voyages, howsoever caused.

FOR YOUR INFORMATION

- The yacht will be under the command of a Skipper holding a certificate of Competence.
- The life saving, safety and fire-fighting equipment carried on the yachts conform to the Code of Practice for Small Commercial Vessels as laid down by the Maritime and Coastguard Agency.
